

# 2023 Excellence in Manufacturing Award presented in partnership with MAGNET



Born in 2011 in a 300 square foot, make shift plastic greenhouse in Kirtland, Great Lakes Growers has evolved into a 160,000 square foot highly automated, hydroponic greenhouse production facility specializing in leafy greens and herbs. After guickly realizing the potential of the business, Great Lakes purchased 20 acres of land in Burton in 2012 and built its first 60,000 sq ft, a high tech greenhouse. The business grew quickly, and in 2015 added another 30,000 square feet and also continued to make investments to further automate its processes. In 2019, Great Lakes Growers expanded an additional 70,000 square feet and added the infrastructure that would allow the company to rapidly expand over the next decade. Great Lakes Growers is preparing to expand an additional 60,000 square feet by winter of 2023.

Great Lakes Growers focuses on the Midwestern marketplace and boasts the nation's broadest product line focused on both retail grocery chains as well as food service distributers.

The company utilizes several interconnected automated processes ranging from water fertilization and sanitation, automated climate and lighting control, automated transport and spacing of the plants as well as automated packaging. As a true innovator in his quest to create the highest quality produce in the most efficient and profitable manner possible, John Bonner continues to make the necessary improvements and investments in automation and people to make that goal become reality.
